Rules:	Weekly progress photos and check ins with current weight are required on Mondays either via email to <u>coordinator@allenaestheticsurgery.com</u> or in person at Allen Aesthetic Surgery, PA. You must call by the Friday before to schedule a time for check in. (919) 676 5052
Meals:	Participants in the AA Challenge benefit from a discounted rate on meals at North Raleigh Clean Eatz location. Price per meal \$6.10 vs \$7.60 per meal with no minimum order. Participants must show proof of participation in the AA Challenge (tokens or cards are given to participants)
Rules are Subject to Change:	Please note that Challenge Rules are subject to change. The AA Challenge contestants will be notified of any changes via social media. It is the contestant's responsibility to check Allen Aesthetic Surgery's social media pages for updates.
Prizes:	Top 3 participants with biggest body change or transformation will be chosen for free consultation at Allen Aesthetic Surgery, PA.
